F Position Descriptions

- Serve as a liaison between the Community of Faith and the Oversight Council.
- Attend Oversight Council meetings in order to stay up to date with the Council's activities.
- Participate on the Oversight Council with full voting privileges
- Share ideas, guidance and expertise with the Oversight Council.
- Potentially facilitate special projects and accept duties as needed by the Oversight Council
- Respect, uphold, and support collective Oversight Council decisions
- Maintain confidentiality of all Oversight Council deliberations.
